Debates revolved around topics related to the elaboration and implementation of environment policy in a continuously changing economic context; the correlation of educational and research objectives to identify the skills and knowledge necessary in a competitive ecological economy. The conference was attended by researchers, academic staff members, representatives of public administration, entrepreneurs and advisors in the field, who shared their experience and expectations and discussed about increasing awareness of environmental compliance.

Forum for Sustainable Development and Entrepreneurship - FSDE 2019

On March 11-15, 2019, the Aula Magna of the Bucharest University of Economic Studies hosted the **Forum for Sustainable Development and Entrepreneurship – FSDE 2019**. "FSDE represents the message of Romanian academics, representatives of the business environment and youth who desire a change in society. Hence, this platform for debate was created in 2014, providing participants with the opportunity to present their informed arguments", said PhD Prof. Nicolae Istudor, ASE's Rector, on the opening of the Forum.

The aim of the project is to generate synergies between the academic environment, the business sector and state institutions, with the active involvement of students, so as to train and help the latter become important actors on the labor market. Among the objectives of the Forum, we mention: the development of relations between the members of ASE's academic community and government representatives to foster efficient cooperation between the two parties, the interconnection of specialists from various fields to develop government and business strategies and to inform students on trends in the economic environment and challenge them to actively participate in debates.

During the event, each of ASE's Faculties organized a series of debates related to their fields of study and research, as follows: "The Capital market in Romania – opportunities and challenges" (Faculty of Finance and Banking); "Entrepreneurship challenges on the Romanian business environment" and "Business Angel: option, opportunity, obligation" (Faculty of Management); "Digital Transformation: challenges for international business" (Faculty of International Business

and Economics); "Energy Security in the Black Sea Region" (Faculty of Administration and Public Management); "Careers in Business and Tourism" (Faculty of Business and Tourism); "Trends in Accounting and Auditing" and "The link between accounting higher education and the demands of the business environment" (Faculty of Accounting and Management Information Systems); the fifth edition of the Economics Symposium on "Perspectives of digital economy in Romania" organized in cooperation with the National Grand Lodge of Romania (MLNR), with the support of the Economists' Guild, as per the partnership between MLNR and the academic environment; "Sustainable Entrepreneurship: The Future" (Faculty of Marketing); "Economic Convergence in the European Union in the context of Brexit and other challenges" (Faculty of Theoretical and Applied Economics); "New Economic Models in the Health Industry in the context of developments in computational medicine" (Faculty of Economic Cybernetics, Statistics and Informatics); "The Internationalization of Romanian Capital" (Foreign Trade Excellence Centre); "Competitiveness of Agrifood Chains" (Faculty of Agrifood and Environmental Economics). Open Days events at ASE

On March 25-29, 2019, ASE organized the 6th series of **Open Days events** for senior pupils from national and economic high schools and colleges from Bucharest and elsewhere, who are interested in becoming ASE's students this year. Visitors had the opportunity to interact with teachers and students, to be informed in detail about the educational offer of the 11 Faculties that organize Bachelor's programs, as well as about the 2019 Bachelor's Admission procedures. Pupils and accompanying teachers were also offered guided tours of ASE's Palace in the center of Bucharest - amphitheaters, reading rooms, sports rooms, the cafeteria and other key places in ASE's Campus. During the week, ASE's Palace was visited by more than 2140 pupils from 40 colleges/ high schools in Bucharest and the counties of: Argeş, Bacău, Călăraşi, Constanţa, Dâmboviţa, Giurgiu, Ialomiţa, Ilfov, Olt, Prahova, Teleorman, Vaslui and Vâlcea.

We hope that many of the pupils whom we received with open arms this week become our students in the coming future!



Interdisciplinary Olympiad "ASE for high school pupils" – first edition

On March 26, 2019, ASE organized the **first edition of the Interdisciplinary Olympiad** "ASE for high school pupils", together with its partners from the pre-university education environment - the "A.D. Xenopol" Economic College and the "Tudor Vianu" National Informatics College in Bucharest.

The project entitled "Today's pupils, tomorrow's professionals" – an Economics contest organized by ASE and the "A.D. Xenopol" Economic College - comprised the following competitions: a Practice Firm Fair (with the following sections: "The best stand", "The best catalogue", "The best PowerPoint presentation / The best negotiator", "The best business video", "The most professional promotional materials", "The best slogan"), as well as a written test on Accounting (for 11th and 12th grade pupils) and Tourism (for 11th and 12th grade pupils).

The essay contest entitled "Through the Labyrinth of Economic Science", organized by ASE in partnership with the "Tudor Vianu" National Informatics College, was open to all pupils in the 10^{th} to the 12^{th} grade interested in testing their theoretical knowledge in Economics. The essays covered topics from the following areas: Microeconomics, Macroeconomics and Entrepreneurship.

The opening and award ceremonies were attended by PhD Prof. Nicolae Istudor, ASE's Rector, PhD Prof. Dorel Paraschiv, Vice-rector for Liaison with the economic and social environment and cooperation with students, Ionel Florian Lixandru, State Secretary at the Ministry of National Education, prof. Mihaela Iacoban, Director of the "A.D. Xenopol" Economic College, prof. Claudia-Elena Anghel, Director of the "Tudor Vianu" National Informatics College, teachers and academics, pupils and students from ASE, as well as representatives of the sponsors and

strategic partners of ASE, who supported the events and awarded prizes to the winners. One of ASE's strategic partners offered a laptop to one of the winners.

Out of the 700 participating pupils, awards were granted to pupils from 15 high schools and colleges in Bucharest and 3 high schools and colleges from other places in Romania. For the contests in the three aforementioned disciplines – Tourism, Accounting and Economics – there were 7 first prizes, 4 second prizes, 5 third prizes and 15 special mentions. The Practice Firm Fair comprised 32 stands, and reunited 340 pupils, who competed for first, second and third prizes in each of the 6 above-mentioned sections.













Approval of the Rector's Report during the meeting of the University Senate

During the meeting of the University Senate from March 27, 2019, the **Rector's 2018 Annual Report on the state of the university** was presented, debated and approved. ASE's Rector, PhD Prof. Nicolae Istudor, presented the activity of the Board of Trustees and of ASE's entire academic community, the attainment of performance indicators undertaken as per the 2016-2020 Managerial Plan, and the results obtained in 2018. The Report was unanimously validated by the members of ASE's University Senate.

stability, the banking system, insurance. The best three papers authored by Doctoral students were awarded money prizes by the Romanian Association of Finance and Banking (RoFIBA)





ASE's Finance and Banking team - winner of the CFA Research Challenge Romania

ASE's students were coordinated by PhD Prof. Anamaria Ciobanu and supported by Andreea Mladin (mentor on behalf of CFA, alumna of the Master's program in Financial Management and Investments).

The team of FABBV students will participate in the regional contest of the "CFA Institute Research Challenge", which will take place on April 10-11, 2019 in Zürich, Switzerland.





ASE-UNECON Joint academic conference on "Food security"
