ASE in Times Higher Education World University Rankings by Subject 2020

According to the **Times Higher Education World University Rankings by Subject 2020**, released on November 6, 2019, the Bucharest University of Economic Studies is ranked **501**+ in **the field of Business & Economics** and **601**+ in **the field of Social Sciences**. Besides ASE, other member universities of the "Universitaria" Consortium hold similar positions: the "Alexandru Ioan Cuza" University of Iaşi, the "Babeş -Bolyai" University of Cluj and the University of Bucharest. The ranking analyzes the best research-intensive universities in the world, on the following criteria: the quality of the teaching and learning environment; research volume, income and reputation; research influence; the degree of internationalization, and industry income.



Free-of-charge optional courses for first year students

As a token of its student-centered academic policy, as per a Decision of the Board of Trustees, ASE offers first year Bachelor's students **free-of-charge optional courses in Microeconomics and Mathematics**. The courses are held on a weekly basis throughout the first semester of the current academic, starting November 1.

ASE International Knowledge Fair 2019

On November 4-8, 2019, ASE's Department for International Relations organized the third edition of "ASE International Knowledge Fair 2019". The program included a series of information sessions regarding international mobilities and opportunities for student scholarships abroad: Fulbright scholarships, French governmental scholarships, mobilities in the Russian Federation, DAAD scholarships and Erasmus+ opportunities. Moreover, the program included workshops on UEFISCDI, DAAD, Erasmus+ international research and mobility opportunities for academics and researchers, as well as talks on means of enhancing the University's visibility on international rankings.





Training sessions – the accessing of the Eikon platform for students (Thomson Reuters)

On November 6, 2019, ASE's Library, in partnership with Refinitiv SA (Thomson Reuters), organized a **training session** to present user facilities for the specialized "Eikon for students" platform that our institution has access to. The training session was facilitated by Chris Livadas (CEE at Refinitiv) and included the presentation of the "Datastream" specialized component. The event was attended by Bachelor's, Master's, Doctoral students and academics, users of this specialized electronic resource available at the Library's Periodicals Room.

Starting November 2019, the Bucharest University of Economic Studies benefits for a year from a new access license to the "Thomson Reuters Eikon for Students" database (part of the portfolio of *Thomson Reuters Financial & Risk Business*, now *Refinitiv*), acquired by means of the project entitled "Developing entrepreneurial skills for Doctoral and Postdoctoral students in Economic Sciences - POCU/380/6/13/125015".





SoNoRo Festival hosted by ASE

The event was organized with the support of ASE's Faculty of Marketing. 
Periodical Basic First-Aid Classes





ASE's Delegation's visit to Egyptian universities

On November 14-19, 2019, **ASE's Delegation**, comprising PhD Prof. Nicolae Istudor, Rector, PhD Prof. Marius Profiroiu, Vice-rector for International Relations, and PhD Prof. Dumitru Miron, Vice-president of the University's Senate, **went on a documentation visit to Egypt**, following the invitation extended by **President Abdel Fattah El-Sisi**, **ASE's Doctor Honoris Causa**.

ASE's Delegation visited four leading Universities from Cairo: Cairo University, Technology University of New Cairo, German University and Coventry University (member of "The Knowledge Hub" in Egypt), to analyze with Egyptian partners the opportunities for undertaking joint research projects, student and staff exchange, study programs in the field of Business Administration and Economics. During the meeting with Mohamed Othman Elkhosht, President of the Cairo University, the topmost Egyptian state university, with 28 Faculties and ca. 300.000 students, it was convened to conclude a Memorandum of Understanding and an Erasmus+Agreement. Moreover, ASE's Delegation also had a working meeting with Dr. Khaled Abdel Ghaffar, Minister of Higher Education and Scientific Research.

On November 16, 2019, **ASE's Delegation was received by Egyptian President Abdel Fattah El-Sisi**, ASE's Doctor Honoris Causa. The President of Egypt welcomed the Romanian delegation and appreciated the long standing relations between the two countries, extending over more than a century. Discussions focused on issues regarding the consolidation of these relations, cooperation in education and culture, especially by means of researcher scholarships and exchange, and by the conclusion of academic cooperation agreements between ASE and Egyptian universities offering similar disciplines.

Debates focused on Romania's financial standing against macroeconomic disequilibrium, and solutions for preventing fiscal chaos.
